1. Booth registrations are confirmed by receipt of this application/contract before February 24, 2012 when accompanied by check, credit card or money order. **Space is limited, first come first serve.** If you would like the same booth as last year then you need to get your application to us prior to February 1, 2012.
2. Booth cost is \$175.00. This 10' x 10' space entitles you to 1 table (8') and 2 chairs. Booths are \$150.00 if confirmed by February 5, 2012. Electricity is available for an additional fee. Number of spaces with electricity is limited.
3. Only one firm or entity may occupy each booth. This includes casual instrument traders.
4. All exhibits must be left in place through 2 pm, Saturday. No booth dismantling will be allowed. **NO EXCEPTIONS. No vehicles are allowed on the show floor from 8:45am to 4:00pm. NO EXCEPTIONS.**
5. CE Distribution will not assume responsibility for any theft, damage, accidents or deals that may occur during the course of the show or during set up or break down.
6. CE Distribution may refuse a booth application for any reason, disclosed or nondisclosed.
7. Sales or display of illegal, unlicensed or "bootlegged" goods is expressly prohibited. This includes but is not limited to audio, video, printed and/or manufactured items.
8. The show is completely outdoors and no covering of any kind is provided. You are welcome to provide your own booth canopy or pop up, as long as it fits the confines of your booth. The show is a rain or shine event. **No refunds regardless of any circumstance, including rain.**
